

Memorandum of Understanding

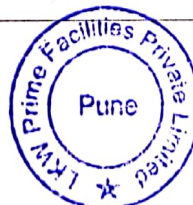
This Memorandum of Understanding (the "MOU") is entered into 09 January 2026, by and between LKW Prime Facilities Pvt Ltd, with an address of PAP/IS 118, Ranjangaon MIDC Shirur, Ranjangaon Ganpati Tal- Shirur Dist-Pune 412209 and Shri Dhokeshwar College with an address of Takali Dhokeshwar Tal- Parner Dist- Ahilyanagar 414304, also individually referred to as "Party", and collectively "the Parties."

WHEREAS, the Parties desire to enter into an agreement to Coleege Pass Out Student Recruitment Campus ; and

WHEREAS, the Parties desire to memorialize certain terms and conditions of their anticipated endeavor;

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein, the Parties agree as follows:

1. **Purpose and Scope.** The Parties intend for this MOU to provide the foundation and structure for any and all possibly anticipated binding agreement related to Shri Dhokeshwar College Pass out Student Recruitment Campus.
2. This MOU should not establish or create any type of formal agreement or obligation. Instead, it is an agreement between the Parties to work together in such a manner to encourage an atmosphere of collaboration and alliance in the support of an effective and efficient partnership to establish and maintain objectives and commitments with regards to all matters related to College Pass out Student Recruitment Campus.
3. **Objectives.** The Parties agrees as follows:
 - 3.1. The Parties shall work together in a cooperative and coordinated effort so as to bring about the achievement and fulfillment of the purpose of the MOU.
 - 3.2. It is not the intent of this MOU to restrict the Parties to this Agreement from their involvement or participation with any other public or private individuals, agencies, or organizations.



- 3.3. The Parties shall mutually contribute and take part in any and all phases of the planning and development of Student Recruitment Campus to the fullest extent possible.
- 3.4. This MOU is not intended to create any rights, benefits, and/or trust responsibilities by or between the Parties.
- 3.5. The MOU shall in no way obligate either Party to supply funds to maintain and/or sustain any specific project or activity.
4. **Term.** This Agreement shall commence upon the Effective Date, as stated above, and will continue until 31 December 20026.
5. **Termination.** This Agreement may be terminated at any time by either Party upon 30 days written notice to the other Party.
6. **Indemnity.** The Parties each agree to indemnify and hold harmless the other Party, its respective affiliates, officers, agents, employees, and permitted successors and assigns against any and all claims, losses, damages, liabilities, penalties, punitive damages, expenses, reasonable legal fees and costs of any kind or amount whatsoever, which result from the negligence of or breach of this Agreement by the indemnifying party, its respective successors and assigns that occurs in connection with this Agreement. This section remains in full force and effect even after termination of the Agreement by its natural termination or the early termination by either party.
7. **Severability.** If any provision of this MOU is held invalid or unenforceable, such provision shall be severed, and the remaining provisions shall remain in full force and effect.
8. **Waiver.** Failure by either Party to enforce any provision of this MOU shall not be deemed a waiver of future enforcement of that or any other provision.
9. **Legal Fees.** In the event of a dispute resulting in legal action, the successful party will be entitled to its legal fees, including, but not limited to its attorneys' fees.
10. **Legal and Binding Agreement.** This MOU constitutes a legal and binding agreement between the Parties. Each Party confirms that it has full authority to enter into this MOU.
11. **Governing Law and Jurisdiction.** This MOU shall be governed by and construed in accordance with the laws of India, and the courts of Pune, Maharashtra, shall have exclusive jurisdiction.
12. **Entire Agreement.** This MOU represents the entire understanding between the Parties. Any modifications must be made in writing and signed by both Parties.
